Energy Efficiency Rehabilitation Program

Financial assistance for costs related to housing energy efficiency and rehabilitation for providing safe, decent and energy efficient living conditions. The city is now offering forgivable loans of up to \$30,000 for energy saving home upgrades. Many common home renovation projects qualify and if you live in your home for 10 years, the loan does not need to be repaid.

Energy Conservation Loan Program:

Connecticut may also provide you with a low interest loan for your system. Eligible families can borrow up to \$25,000 for 10 years at low interest rates between 0 percent and 6 percent.

Tax Exemptions for Renewable Energy Equipment:

Thanks to some helpful CT tax breaks for solar, you won't even have to pay any taxes on your new solar panels. The <u>Sales and Use Tax Exemption for Solar and Geothermal Systems</u>, for example, means that you won't have to pay any taxes on the purchase of your system. Additionally, the <u>Property Tax Exemption for Renewable Energy Systems</u> keeps you from having to pay any additional taxes on the increased value of your home.

Federal Tax Credits

Did you know you might be able to take advantage of federal income tax incentives for solar energy systems? Under the Bipartisan Budget Act of 2018 which was signed in February 2018, many tax credits for residential energy efficiency that expired at the end of 2016 were renewed. Tax credits for all residential renewable energy products have been extended through December 31, 2021.

Tax Credits for Solar

- 30% for systems placed in service by 12/31/2019
- 26% for systems placed in service after 12/31/2019 and before 01/01/2021
- 22% for systems placed in service after 12/31/2020 and before 01/01/2021
